About the Event

National Level Capacity Building Workshop for Child Rights Social Workers on Combating Child Labour and Child Trafficking will be held on 18th and 19th August 2016 at Christ University, Bengaluru. This workshop is organized by the India Network of Professional Social Workers' Associations (INPSWA) in association with Dept. of Social Work, Christ University, Child Rights Trust (CRT), Indian Society of Professional Social Work (ISPSW) and Karnataka Association of Professional Social Workers (KAPSW). The event is sponsored by International Federation of Social Workers - Asia Pacific Region (IFSW-AP) and co sponsored by the Japanese Centre for Social Welfare Promotion and National Examination, through Japanese Coordinating body for IFSW membership. The workshop is a key opportunity for practicing social workers, social work students and faculty, government interveners and policy makers to learn from experts in the field of child rights. Experts from the field will share knowledge gained through field work, research and good practices in Government, Non Government and International Organizations to combat, rescue, repatriate and rehabilitate child labour and victims of child trafficking and promote active engagement of children in education and development with rights. This is the first workshop conducted in collaboration with IFSW and Indian organizations.

Programme

The workshop will commence on Thursday, 18th August 2016 with inauguration and a power packed keynote address will elaborate the issues in four sessions.

1. Policy framework (Global, National and Legal framework)
2. Field realities in combating child labour and child trafficking
3. Experience sharing about a few successful interventions and replicative models
4. Current and future challenges in tackling child labour and trafficking of children

This will be followed by a group discussion to develop suggestions and recommendations from tackling field issues to policy revamping. The programme will end on Friday, 19th August 2016 in the evening with a valedictory. Detailed programme will follow.

You are invited to take part in this topical workshop

This is a special forum created for knowledge exchange and to build new ideas to combat the issue of child labour and child trafficking to reach out to national, international goals and standards and to create a India with child rights. Some of the leading practitioners, administrators, policy advocates and academicians are making presentations to share their experiences and thoughts. An exhibition on problem interventions and successful stories is also part of the workshop. Many networking activities are a possibility with 50 participants, resource persons from across the country and IFSW representatives. The organizers are providing limited assistance to outstation candidates - shared accommodation and 3 tier train fare reimbursement.
