I was nominated to be the EAPN representative at the 2015 delegates meeting in Edinburgh. I have been a member of an EAPN Task Force on Poverty and Human Rights for the past 2 years. This group has produced a Handbook on Poverty and Human Rights, which is in the process of being published.

In October 2017, I attended the EAPN General Assembly in Dublin giving a presentation on the Handbook and contributing to a discussion on the role of European Organisations to Policy development. I have also contributed to consultations particularly the Pillar of Social Rights and ensured that information about EAPN work is sent to IFSW members. At the last IFSW meeting the Executive meeting, I recommended that IFSW members link in with EAPN national networks and did a survey looking at the current position and how IFSW could contribute more effectively both at a European and national level. I feel that I have made good links with EAPN and would like the opportunity to continue to develop this further and continue to represent IFSW-E on EAPN.
