## CONCEPT PAPER

**Background:** In the background of World Social Work Day 2019, Association of Professional Social Workers & Development Practitioners (APSWDP) and Rajiv Gandhi National Institute of Youth Development Regional Center, Chandigarh in technical partnership with State Legal Services Authority (SLSA), Chandigarh, School of Public Health, PGIMER, Chandigarh, Punjab Energy Development Agency (PEDA), Centre for Social Work, Panjab University, Chandigarh and The Climate Reality Project-India has planned to mark and observe the global day among social work students for strengthening Social Work Profession in the country and also organize a Capacity Building & Training Workshop on Effective NGO Management and Sustainable Development Goals for Local Actors, Grass Root Youth Network and Organizations from progressive states.

Youth can play a decisive role in promoting the Sustainable Development Goals (SDGs) by 2030. They can significantly contribute to tackling global issues with their imagination, energy, and appropriate advocacy strategies. They have great potential to positively impact the society by adopting Think Global and Act Local.
