Since 2009 I am organising the National Conference in Social Work in Romania. In 2019 I was honoured to be part in the organisation of the IFSW European Conference in Vienna, Austria. Since 2018 I have been invited and honored to attend the national conferences of many IFSW Europe members.

Since 1995, when I started wot work as social worker, I initiated or manage more than 30 projects that were connected to social work and the development of social services. More than 10 of these projects were national strategic projects. A part of them are listed in my CV.

Since 2008 I am the manager of the Center for Training and Assessment in Social Work (CFCECAS) Romania, President of the IFSW Europe since 2018. Since 2014 I am the Founder and President of the Association of Social Workers in Romania (ASproAS).

I was working as volunteer in the community for developing integrated community services. Since March 2020 I am coordinating, as volunteer, the Helpdesk for social workers and social services in Romania for providing support to people affected by COVID-19.

- 2015 providing support and counselling to victims of abuse;

This is a program provided in schools by social workers. Since 2014 over 15,000 children from all over the country benefited from this program.
