I have experience in Urban and Regional Planning, acting on the following subjects: social work, social work education, social work research, urban and regional planning.

I have been part of the faculty of Social Work, at the Federal University of São Paulo (UNIFESP), at the Graduate program, since 2011 and at the postgraduate program since 2016, where I develop researches, teach disciplines and participate in councils, commissions and consulting spaces.

Professional Leadership Experience over the past decade

In 2012, I was appointed by the peer of the faculty of Social Work, coordinator of Social Work Practices, a space I was reappointed in 2014, ending the management in 2016.

In 2014, I assumed the vice-leadership of the Department of Public Policies and Collective Health, for three years. In 2016, I took the vice coordination of the Social Work course, whose management was completed in 2018. Currently, I am a member of the Teaching Structure Nucleus of the Social Work course and I represent the Health and Society Institute of UNIFESP Baixada Santista at the University's International Relations Secretariat.

National Association and Leadership Experience over the past decade

I was a counselor 1a. Secretary of the Federal Council of Social Work (CFESS), management from 2014 to 2017 and 2017 to 2020, a place where we defend the human rights, the development of democracy as socialization of the political participation, and the equity and social justice, principles of our Social Worker's Code of Ethics. We did a lot of actions in guiding professionals in the defense of the universality of access to good and services related to social programs.

I am Vice President for Latin American and Caribbean, of the International Federation of Social workers (FITS) management 2018-2020.

I am part of the GTP Urban, Agrarian and Environmental Question and Social Work, of the Brazilian Association for Education, Research in Social Work (ABEPSS).

I have represented CFESS in the national coordination of the National Urban Reform Forum (FNRU), an NGO which defends the right of the cities, in a collective way rather than an individual right, since 2005 until 2020.

1. In the field of health, we work against many social indicators that explain the social inequalities in the access of the black and poor people to the unified health system, mainly in this time of COVID-19.

- 2. In the field of education, these inequalities are even greater, and we fight against the exclusion of black and poor people from the knowledge production process.
- 3. We are experiencing, in Brazil, an intense process of deconstruction of social policies and destruction of the rights and our association has the role of fight against these.

Although the language of our member countries is mainly Spanish, we also have members whose language is Portuguese (Brazil) and English (Grenada and Haiti). We have a similar situation in political and economic situations. And our knowledge and training in social work and its demands is similar too.
