- 1) To promote social work training and practice in Zambia, As Secretary General of the national Association, I have since 2005 played a key role in revitalizing the national association in Zambia as well as contributed into developing systems and process to the level to which the organization is today. The national association under my leadership as Secretary and CEO is now a well-respected professional body in the country providing much needed technical guidance to the Government. I have also been able to establish partnerships with other NGOs including the UN agencies who have since 2017 been able to implement joint project with my National Association.
- 2) As Regional Vice President for IFSW Africa, I have been able to contribute to raising the profile of the profession in Africa as well as supported a number of national associations set up governance systems. In collaboration with colleagues in the region, we have been able to help raise the voices of social work practitioners in Africa to share their practice stories. This has helped to sensitize society to appreciate that Social workers make a unique, professional and critical contribution to society.
- 3) In line with the aims of the Federation as laid down in IFSW Constitution, I have been able as IFSW Africa Region Vice President to facilitate standing partnerships with other stakeholders such as the UN agencies like

UNICEF as well as NGOs. During my tenure as Vice President, our regional conferences have been held collaboratively with other national and regional stakeholders. As regional leaders we have been able to progressively and proactively build internal and external partnerships with people who use social work services and their wider communities.

- 4) As Regional Vice President for Africa, I have played a leading role in advancing advocacy initiatives against human rights violations. Examples in point are some of the statements published on IFSW global website highlighting human rights violations in the Cameroon, Zimbabwe and Uganda to mention but a few.
- 5) As Regional Vice President, I have made significant contributions in ensuring that a number of national associations in the region join the federation whilst at the same time supporting new members to set up clear governance and financial systems to effectively operate as an organization.
- 6) As Regional Vice President, I have attended all global executive committee meetings and adequately represented the Africa Region. I have also contributed to highlight the African social work practice aspect inspired by "Ubuntu" philosophy thereby contributing to shaping the global narrative of social work training and practice that is interested in incorporating indigenous knowledge.
- 7) I have also been involved in the Africa region study landscaping the social welfare workforce and the extent to which social is being recognized as a profession in Africa. This exercise was done in partnership with UNICEF Eastern and Southern Africa (ESARO) and the Global Social Service Workforce Alliance (GSSWA).
- 8) Each of the above actions has significantly assisted the development and strengthening of social work profession in the region.
- 9) As Regional Vice President for Africa, I have spoken at a number of fora including the 2019 World Social Work Day commemoration at the UN in Geneva, virtually spoke about "Ubuntu" during the 2021 World Social Work Day at the UN as well as made Podcast presentations for 2021 World Social Work Day commemoration for the British Association of Social Workers.
- 10) I have also been a Guest lecturer to social work students at Lucerne University of Applied Sciences and Arts in Switzerland as well as virtual Guest lecturer for social work students at the University of Barcelona in Spain. All these opportunities helped create a platform for sharing our African social practice experiences and how that our practice environments mode and shape our practice methods. Key lessons shared with social work students was that our practice wisdom was largely influenced by our practice environment thereby contributing significantly to our training and practice outcomes.

Under the stewardship of the nominee as Secretary General and Chief Executive Officer, The Social Workers Association of Zambia (SWAZ) was re-established and has built governance and financial systems and procedures which makes it operate as an organisation. SWAZ currently employs 15 staff on contract under a USAID systems strengthening project. The USAID funded ACHIEVE being implemented by SWAZ aims to support the Governments' department of social welfare to strengthen a social protection system that supports vulnerable children, adolescents and their families especially those affected by HIV and AIDS.

The national Association of Social Workers has consistently been a member in good standing of the IFSW.

As Vice President of IFSW Africa Region, I have tirelessly supported my regional President raise the profile of the region, bring on board new members to the Federation, support individual national associations as well as facilitate successful regional conferences. I have demonstrated the character of a leader that leads from the front by spearheading conference planning, conference resource mobilisation as well as network and partnership building at national and regional level. I have also been instrumental in the introduction of the regional webinars that promotes sharing of practice experiences by social work practitioners within the region. I believe that the zeal that we have been able to resuscitate in the African social workers will live beyond our legacy and that the profession in Africa will continue growing to higher heights.
