My commitment has been longstanding and today, as IFSW European Vice-President, I see that the work of the IFSW has never been more important given i) Covid-19 and ii) the level of uncertainty; strife; and the political, social and economic difficulties that blight the lives of so many people and communities across the world. 'Leaving No One Behind' is more urgent than ever and IFSW can build on its contribution to ensuring this goal is achieved.

As the current IFSW Europe Vice-President and prior to that role, I have participated in many projects of the IFSW European Regional Executive. The core aims of these projects have been and are based on the need to promote social justice and human rights; fight injustices and inequities and support social workers and IFSW member organisations across Europe.

I believe that my involvement in the IFSW-European Region has supported the building of partnerships and connections (for example, the EU Social Platform, EAPN and more recently, Eurochild), joint action and advocacy work.
