Graduated in Social Work from the School of Social Work of the State of Zacatecas, Mexico in 1989, with a Master's degree in Thanatology from the Humanist Growth Centre in Zacatecas, in 2017, and a Doctorate in Thanatology from the same Humanist Growth Centre. I have experience in Social Work in health, as well as Health Services Administration and Social Management.

I am part of the College of Social Workers of the State of Zacatecas, since 2017, I am also a teacher in the school of Social Work of the Carlos Coquí Institute, since, I am a member of the Board of Directors of the Federation of Colleges and Associations of the State of Zacatecas (FECOAPEZ). And currently I am the president of the National Federation of Colleges of Mexican Social Workers United by the guild, A.C. (FENACOTSMEX), I am a member of the Board of Directors of the College of Bioethics of Zacatecas (COLBIOZAC).

Currently, I am working on the implementation of Social Work in Palliative Care in the Ministry of Health of Zacatecas.

I assumed the Coordination of Research Ethics Committees and Administrative Coordinator in 2018 and until February 2024, in the State Council of Bioethics of the Secretary of Health of Zacatecas.

From 2013 until 2018, I was appointed State Chief of Social Work of the State of Zacatecas, in the Ministry of Health.

Prior to that, I was head of the Social Work Department at the Luz González Cosió General Hospital in the State of Zacatecas.

I have been teaching a Bachelor's Degree in Social Work since 2018, at the Dr. Carlos Coquí Institute.

• Experience of the National Association and Leadership over the last decade

I am the founder and first president of the FENACOTSMEX, I have achieved the constitution of more schools in Mexico, in order to have one for each state of the Republic and affiliate to the Federation.

I was the first founding president of the College of Social Workers of the State of Zacatecas, now affiliated to the Federation.

Push for the proposed Professional Practice Act through the federation, for professional recognition and labour justice.

I am promoting certification for social workers in different areas in order to guarantee society a coherent, efficient and effective professional practice.

With the support of the presidents of the federation's colleges, I managed to get FENACOTSMEX to join the International Federation of Social Workers, in order to adhere to the work agenda and the code of ethics of this organisation, and also to participate not only nationally but also regionally and internationally.

• Community/volunteer and leadership experience over the last decade

I have been involved in villages in order to have electricity installed in them, as they are far away from the capital, so access to electricity is not easy.

I work with groups of people of Huichol origin to help them with problems and cancer in programmes for minors, as well as taking them on trips to fulfil their dreams through the Civil Association "hay vida en mis sueños" (there is life in my dreams).

1. To promote the law on the professional practice of social work in the country, so that it can be approved in the Senate of the Republic.

2. In the field of health, we are working against many social indicators that explain the social inequalities in the access of black and poor people to the single health system, especially in these times of COVID-19, as well as to be prepared for those that may arise, and in education these inequalities are even greater, so the Federation is working on policies to provide greater coverage in this area.

3. We are living, in Mexico, an intense process of deconstruction of social policies and destruction of human rights, and FENACOTSMEX has the role to fight against it.

It is important to note that we will continue to strengthen the International Federation of Social Workers at the Latin American and Caribbean level.
