MASW has been a member of good standing of IFSW since 1974, and I have personally participated at the Joint Global Conference, as well as attending the IFSW General Meeting in 2010, 2014, 2016, 2020 (online), and 2022 (online), as well as involvement as regional representative to the Ethics Commission (2016-2020) and Education Commission (2023 to date).

I have been active in attending the regional conference, and the ASEAN Social Work Consortium (ASWC) Conference (2016 to date), ASEAN GO-NGO Forum on Social Welfare and Social Development (2015 to date). I have also served under different Regional Presidents since 2016 in various capacities. My affiliation with ASWC, COSW and ICSW has given me to network with many other social workers and leaders in the region. The recognition of social work as a profession in the region varies and many countries are moving towards legal or statutory professional recognition. Regional issues include disaster response, migrant and refugees, poverty, child protection, gender-based violence, and elderly care. The region is very diverse in terms of its ethnicity, culture, politics, economics and language. Coming from a multi-ethic, multi-religions and multi-cultural country and having visited approximately 16 countries in the region, I believe I have good understanding of the dynamics of the region. English is widely used in most part of the region and within IFSW-AP, APASWE and ICSW, and is also the official language of ASEAN and at the UNESCAP in Bangkok. Nonetheless, simultaneous translation into other global languages such as Japanese and Chinese are common practice in many regional conferences and meetings.

Besides attending the IFSW-IAASW-ICSW Joint World Conference since 2010 and IFSW-AP Regional Conference since 2016, I also have participated, in various capacities, in other international conferences and meetings, including ASEAN, APEC, Non-Alignment Movement (NAM), Commonwealth Heads of Government Meeting (CHOGM) since 2004. I am familiar with the processes and dynamics of many of these international meetings as well as the issues and agenda, including the United Nation Sustainable Development Goals (SDGs), and the Global Agenda on Social Work and Social Development.
