a, World Social Work Day 2024. John Mary noted that the World Social Work Day 2023 was,

- In total Attracted up 17 Universities, 784 students and staff, and 7 social work agencies, government departments and CSO in the three celebration centers.
- Well reported on the global platforms like IFSW and GSWA social media platforms-Twitter and Facebook plus all NASWU platforms.
- Strengthened NASWU regional coordination teams, NASWU visibility, and continue to be a major platform for NASWU resource mobilization.

C, Membership and resource mobilization.

- Registered NASWU with a resolution to cover the entire country as opposed to earlier registration as a CBO.
- Attained a certificate of registration (number 8061) and Permit of Operation (permit number 9598) for 60 months from February 2024.
- Updated NASWU information with the Uganda financial intelligence authority.
- Updated NASWU bank account to present key documentation after government had closed many NGOs Account numbers including NASWU.
- Paid IFSW membership fees up to 2024

Resource mobilization and strategic partnerships

- NASWU continue to engage and look for links to possible resource mobilization, partnerships and unsubscribed members.
- NASWU is in talks with Calgary University Canada for possible partnership together with Kyambogo University with the first introduction meeting scheduled for 7th May.
