#### **ENSACT ISTANBUL CONFERENCE**

The 2013 ENSACT conference offered participants a wide range of key note presentations, symposiums and workshop sessions, accompanied by a stimulating and diverse study visit and social program. No formal evaluation of the event was carried out but anecdotal evidence suggests that the 626 participants felt that it had been a very worthwhile and enjoyable experience. Unfortunately anticipated sponsorship was not forthcoming with the result that there was a net loss of 8,551.40 euros. (Expenditure: 221.169.40 euros and Income: 212.618.00 euros).

TASW has accepted responsibility for the deficit

ENSACT now plan to meet twice a year. The next meeting will be held in Utrecht or Paris on 23rd May 2014.

IFSW Europe has commented on a draft statement ENSACT has prepared concerning the network's future mission, vision and focus. Members of the Executive have responded.

IFSW has continued to be a very active member of the European Social Platform. Over the past 12 months the Platform has produced policy papers and effectively lobbied the European Parliament, Heads of Member States and other decision makers about a range of issues affecting social services, notably poverty and social

In the lead in to elections to the European Parliament the Social Platform and colleagues from the trade union movement and other major social development organisations have updated the Spring Alliance Manifesto demanding measures that will secure the future well-being, solidarity and quality employment of all citizens, all within planetary boundaries. Cristina Martins and Ian Johnston represented IFSW E at the Social Platform GA in Brussels on 24th April 2013. Over the course of the year IFSW has made representations to President Barrosso and Heads of all EU Member States about the need to ensure that the target to eliminate poverty and exclusion is retained in future spending plans and Ian and IFSW Europe's Brussels based representative, Dalé Kabasinskaité, have continued to attend the SP Working Groups and actively contribute to the Platform's important work streams.

The annual FRP-meeting took place 10-11 of April 2014 in Vienna.

Very lively discussions and the strong demand on the EU-commission to revise policies with a focus on human rights, social rights, cultural rights. The main task of the coming years will be to restore trust in EU politics and politicians, listening to the demands of people and not only the demands of lobbyists. Another problem is a lack of awareness people have about their rights, specifically victims of domestic violence, hate crimes and children do have little knowledge and awareness. This was found in all investigations published during the last 4 years.

## 10 | PROJECT: ECONOMIC CRISIS IN EUROPE - CHALLENGE AND RESPONSE OF SOCIAL WORK PROFESSION

#### THE MAIN AIMS OF THE PROJECT ARE:

- > To present information about "the response of social workers/social work organizations to the ongoing economic crisis at national levels.
- > To discuss and decide on collective action by member organisations at an international level:
  - Exercise advocacy, empowerment and lobby at European level;
  - Support and engage with member organisations and social workers in countries most

#### **ACTIONS**

- > To start implementing an action-plan for the project
- > Development of a link to liaise the project with the activities for the Global Agenda within the European Region

Members of the project working group are "Hakan Acar, Gabriele Stark-Angermeier, Salome Namicheisvili and Maria Moritz.

The project has been completed in two stages:

- > Collecting Data from members regarding the response of social work to the economic crisis: A questionnaire, drawn up by the working group was sent (in August 2013) to members and 11 members (Austria, Croatia, Georgia, Germany, Iceland, Israel, Portugal, Spain, Sweden, Turkey and United Kingdom) responded.
- > Workshop: Portugal, Austria and Macedonia responded to the formal call to host the work-

shop. Portugal's offer to hold it in Lisbon was accepted and .the Portuguese Association are thanked for making the organisational arrangements and for their hospitality. The meeting took place from Dec. 6-7 2013 and provided an important opportunity for delegates from Georgia, Austria, Germany, Turkey, Croatia, Spain, UK, Ireland, Israel, Russia, Portugal and Romania, to share information about the impact of the crisis in their respective countries. Representatives of EAPN and Eurordis also made presentations in the workshop. This created an opportunity to discuss common ways to work together with other European institutions. The Project Report will be presented at the Delegates meeting.

#### 11 | PROFESSIONAL QUALIFICATIONS DIRECTIVE

# > The Professional Qualifications Directive is essential to enabling professionals to start a new business or to find a job in another Member State requiring a specific qualification for a specific professional activity. The proposal aims at simplifying rules for the mobility of professionals within the EU by offering a European Professional Card to all interested

#### **ACTIONS**

IFSW Europe will continue to contribute actively in the process.

The EU-Commission has launched a call of interest in implementing the European professional card (EPC) and 112 professional associations answered this call, 3 social workers organisations, IFSW-Europe e.V., Association of Social Workers of Greece and from UK the College of Social Work. Unfortunately the commission decided to promote only the extension



professions which would allow easier and faster recognition of qualifications. It also clarifies the framework for consumers, by inviting Member States to review the scope of their regulated professions and by addressing public concerns about language skills and the lack of effective alerts about professional malpractice, notably in the health sector. This proposal was based on the answers on the Green-Paper (2011).

for the professional card to three more professions, engineers, mountain guides, real estate agents (doctors, nurses, pharmacists, architects, dentists, midwives and veterinary surgeons are on the list already). The commission considers that there is more assessment necessary of all other interested associations. The assessment process is scheduled to be started by the first quarter of 2014. Dalé Kabasinskaité represented IFSW at a briefing session in Brussels on the proposed developments on 12th February. The European parliament has voted in favor to extend the EPC to the named three additional professions. Conclusion: there will still be a long way to go for social work to become an automatically recognized profession with implementing the EPC for social workers. It might be helpful for accelerating the process to be recognized as a health-profession. This must be discussed within the profession and IFSW.

On behalf of IFSW, Europe Salome Namicheishvili was presented at the Conference in Antalya, Turkey, 21-25 August, 2013 "Models of Social Work Practice in the Region: Challenges, Achievements and Future Plans". The vast majority of the countries presented at the conference were from the former soviet union where social work practice is emerging. Salome Namicheishvili made a speech on Social Work Ethics as the contact person to Global ethics committee.

#### GLOBAL AGENDA AND AGENDA OBSERVATORY:

the first report about the Agenda activities is to be launched at the 2014 World Conference in Melbourne. This meant a very tight schedule to submit contributions and the experience shows this has to be revised and extended. The European contributions were characterized by the impact of the crisis, low capacity of social workers to engage in additional work on observatory contributions. Regarding the high professional level of social work in europe the output of submitted reports was rather disappointing. The focus in europe was mainly on the impact of social policies and how social work can take

influence to change social policies that are driven by austerity rather than investing in people's potentials. In this context, it is to the credit of social workers around Europe that examples of positive and creative practice can be identified, frequently in projects managed jointly with service users and local communities. Social work practice almost always confronts social and economic inequality and seeks to support people to improve their circumstances and therefore to reduce their inequality. These examples illustrate this in respect of strengthening capacity for employment and earning income (including managing the consequences of economic migration and family breakdown); supporting people to challenge and overcome discrimination as a result of disability, sexual orientation, exclusion from health services and aging; developing proposals to make financial benefit systems work more effectively so as to deliver financial support where it is needed; working to provide the best care and education for children who are not able to live with their natural parents. #### 15 | ENS4Care THEMATIC NETWORK

EVIDENCE BASED GUIDELINES FOR NURSING AND SOCIAL CARE ON THE DEPLOYMENT OF EHEALTH SERVICE

The main objective of the project is the development of evidence based guidelines for the implementation of eHealth services in nursing and social care, building on existing good practices amongst the participants of the Network, sharing and transferring knowledge across European regions.

The ultimate goal of ENS4Care is the establishment of a sustainable mechanism to support nursing and social care research in the field of ICT enabled integrated care.

#### **ACTIONS**

- > To contribute to the preparation of a bid for funding coordinated by **EFN**, European Federation of Nurse, if the bid is successful to ensure that joint guidance produced conforms to social work values and principles and supports and empowers those requiring services.
- > To promote the development of "Social Prescribing" and other preventative approaches and realise the potential of telecare and other specialised equipment to enable people to live independently in their own homes.
- > To disseminate and promote the material produced to our members and the wider social work and social care community utilising the European Social Work Research Observatory, conferences and other training events.

lan Johnston has been representing IFSW Europe on the ENS4Care project which involves 24 partner organisations representing nurses and other health professions, service users and carers. EU funding has been awarded for a 2 year period and lan attended the inaugural partners meeting in Warsaw in December.

A briefing note and request to disseminate an initial questionnaire aimed at identifying services already exploiting the potential benefits of ICT to care situations was sent to member organisations on 21st February and Ian Johnston and Dalé Kabasinskaité attended a General Assembly of the partner organisations in Brussels on 9th April. Members will be provided with feedback on the response to the initial questionnaire and full details about this important project at the DM.

#### 16 | TIMEBANK

Time Banking is an innovative form of reciprocal exchange based on mutual support, and is a highly effective system for promoting active citizenship, the growth of social capital and community empowerment. Time Banks build on strengths, both individual and organisational, and recognise that everyone in a community has something to offer.

Time Banks value all kinds of reciprocal help and skills people can offer each other. There is no exchange of money – the fundamental concept is that everyone's *time* is valued equally: one hour = 1 time credit. Members 'deposit' their time by giving their skills and expertise to others and can 'withdraw' their time credit when they need something for themselves.

Time Banking recognises people and organisations as assets, promotes reciprocity and builds trust and mutual respect between members.

IFSW member organisations with skills and knowledge to offer can choose to join the Time Bank and indicate what resources (a knowledge and skills exchange rather than a financial exchange) they can offer to other members.

A co-ordinator will manage the database of membership and reciprocal exchange activity.

BASW's contribution to the Time Bank may include, for example:

- Recruitment of a co-ordinator, or include the co-ordination role within an existing or proposed administrative post
- Set up administrative systems to broker and record exchanges amongst members
- Monitor and evaluate activity with a view to potentially extending the scheme to
