a) What are the three most important responsibilities towards IFSW:

- 1) Gaining an international perspective and obtaining recognition for the IFSW among member countries as well as non-member countries and other international organizations. Social workers world-wide can be integrated and united through discussions about the definition of social work and its role within the global agenda. I have personally been involved with discussions as to the definition of social work and the IFSW global agenda through regional conferences and at the national committee level and have also made proposals to the IFSW general office.
- 2) Building regional and global solidarity and networks among the IFSW member organizations and individual members of the region for the development of social work ethics, knowledge and practices. The IFSW should assist every region in applying for the IFSW Development Fund to support regional activities such as workshops, research and meetings more openly and actively. The Asia Pacific Region has applied to the Development Fund several times in the past and we have made good progress in building networks within the region.
- 3) Recognizing the economic and socio-cultural conditions and the needs of people all over the world, and supporting the improvement of their well-being.

b) What are the three most important responsibilities towards your Region:

Since the Asia Pacific Region covers a huge geographic area consisting of numerous languages, cultures, and ethnicities, and the stages of social/economic development vary, the needs of people in the region are diverse. With these characteristics in my mind, I would like to pursue the following goals:

- 1) Encouraging non-member countries to join the IFSW by assisting those countries through technical support, such as writing codes of ethics and sharing Japan's experience in establishing a coordinating body.
- 2) Building a stronger network and partnership for improved communication and also facilitating a mutually-supportive relationship among member countries. Our region requires a central office to manage administration work, such as record-keeping and facilitating communication among member countries. Japan is most likely a suitable country to provide this kind of management.
- 3) Recognizing the characteristics and strengths of regional member organizations and building a better and more effective social work strategy for the region in order to enhance the quality of life of people in the region. Japan has contributed in this regard by holding disaster workshops in Hong Kong, Tokyo, Manila and Indonesia to support local social workers, and I would like to continue to work on projects to foster resilience against disasters in the region.

c) What are the three most important responsibilities towards your national association?

- 1) Encouraging the national association to realize that building working relationships within the global social work community, such as through the IFSW, is one way to realize the value of social work and the well-being of different peoples in different national contexts.
- 2) Promoting the interests of international social work among social workers in Japan. I would like to encourage the national associations to get together at local levels for the celebration of Social Work Day in July.
- 3) Japan has been maintaining the regional account as treasurer for a number of years and we would like to expand our duties to the regional secretariat.

Commitment to the goals of IFSW as laid down in the Constitution

I am pleased that I personally, and Japanese members of the IFSW, have been reliable and active members and have made significant contributions to the IFSW-Global and the IFSW-Asia-Pacific as Member-at-Large and as regional leaders with a special emphasis on the regional project of disaster management. I will commit myself, more than ever before, to fulfilling the goals of the IFSW to make the world more just and humane through social work and through the solidarity of a global network of social work professional associations.

Possession of language(s) capabilities (preferably bilingual)

Receiving an English-language education at the master's level in the U.S. and social work education at the doctoral level in Canada, I have acquired bilingual skill in speaking and using English and Japanese in social work practice and knowledge building. I have made presentations at international academic and professional conferences dealing with social work and psychiatric rehabilitation.

I have served as Member-at-Large in the IFSW, representing the Asia-Pacific Region for the past four years. I have also taken a leadership role in the disaster management project funded by IFSW. Most recently, I worked

closely with Indonesian colleagues to organize a workshop on "Disaster Management" in Bandung, Indonesia in January 2014, where I carried out my responsibilities in English.

• Identification with the region you represent, mainly by residence, work experiences, and knowledge of the main language(s) spoken in the region

In the Asia Pacific Region, there are more than 3000 languages spoken. Owing to this linguistic diversity and partially because of the colonial past of many countries of the region, English is commonly used for international communication. I am able to communicate with many social workers in the region using English.

I have lived and been actively involved with social work practice and education in Japan for many years in various areas, namely, mental health, disability, child welfare, women, people with multi-ethnic backgrounds facing social inequality and discrimination, as well as providing multi-levels of support not only in Japan but also in other countries through international networks.

I have attended and organized a number of conferences and workshops, and built an extensive network of social workers in the Asia-Pacific region. Naturally, I have developed a strong identification with the Asia-Pacific region and, more recently, my involvement with the regional projects in disaster management has helped me realize the pressing necessity of stronger solidarity and more consistent cooperation within this disaster-prone region.

• Practical wisdom and objective interest in international affairs

One of my best qualifications is that I have four years of experience as IFSW Member-at-Large. Through this experience of negotiating as a global executive member and closely collaborating with member countries in the region, I have learned how the executive members work with each other and have built-up trusting working relationships.

One of my strengths is that I have been involved with various professional and volunteer activities to work with people from various ethnic backgrounds in Japan, Canada and the U.S. and encountered people with various problems in their respective life stages. The broad spectrum of challenges in their life is much more than people living in one country could ever imagine.

With this lived experience as my background and also with my international and multicultural skills, I am confident in my ability to work effectively with other social workers in the Asia Pacific region. Under the influence of my political science professor when in college, I became involved in the case of a human rights violation toward one African-American man in the U.S. and we were able to gather a petition of 1000 signatures and send this to the president of the United States through international human rights networks. During my stay in Canada, I have also worked with refugees through church committees and worked in an immigrant women service center, as I learned to listen to their voices in a direct and immediate way.

• A willingness and capacity to devote time to responsibilities in the Executive or Regional Committee

I am willing to devote time to head the Executive Committee and to attend the Regional Committee on a regular basis. My present position as a faculty member of Japan Women's University will allow that.

• Ability, in so far as possible, to attend Executive or Regional Committee meetings

I have served on an international committee of the Japanese Coordinating Body for IFSW Membership and I have attended all the Regional Committee meetings as a Member-at-Large for the last four years. I am able to attend Executive or Regional Committee meetings. My university will continue to support my international role in the IFSW for the Asia Pacific Region as well as globally.
