# ECOSOC Commissions, Forums, Conventions & GA High-Level Segment Meetings Commission for Social Development (CSocD)

The CSocD is a functional commission of the Economic and Social Council (ECOSOC) of the UN which consists of 46 elected members. Since the convening of the World Summit for Social Development in Copenhagen in 1995, the Commission has been the key UN body in charge of the follow-up and implementation of the Copenhagen Declaration and Programme of Action. Each year, the Commission takes up key social development themes as part of its follow-up to the outcome of the Copenhagen Summit.

• IFSW delegation attended the 52<sup>nd</sup> session with "policies promoting empowerment of people in achieving poverty eradication, social integration and full employment and decent work for all", as the priority theme. The Commission concluded with the approval of six draft resolutions for adoption by the Economic and Social Council that addressed issues of empowerment, older persons and the family, as well as one text that would hone the Commission's own focus on visual health.

#### Commission of Status of Women (CSW)

The CSW is a functional commission of the United Nations Economic and Social Council (ECOSOC), dedicated exclusively to gender equality and advancement of women. It is the principal global policy-making body. Every year, representatives of Member States gather at United Nations Headquarters in New York to evaluate progress on gender equality, identify challenges, set global standards and formulate concrete policies to promote gender equality and advancement of women worldwide.

- IFSW delegation attended the 58<sup>th</sup> session with the priority theme as "challenges and achievements in the implementation of the Millennium Development Goals for women and girls".
- Participated in four NGO parallel events.

## Commission on Sustainable Development (CSD)

Established in 1992, the CSD is responsible for reviewing progress in the implementation of Agenda 21 and the Rio Declaration on Environment and Development; as well as providing policy guidance to follow up the Johannesburg Plan of Implementation (JPOI) at the local, national, regional and international levels. The CSD meets annually in New York, in two-year cycles, with each cycle focusing on clusters of specific thematic and cross-sectoral issues, outlined in its new multi-year programme of work.

## Permanent Forum on Indigenous Issues (UNPFII)

The United Nations Permanent Forum on Indigenous Issues (UNPFII) is an advisory body to the Economic and Social Council (ECOSOC), with a mandate to discuss indigenous issues related to economic and social development, culture, the environment, education, health and human rights. http://undesadspd.org/IndigenousPeoples.aspx

- IFSW delegation participated in the 13<sup>th</sup> Session with the special theme as "principles of good governance consistent with the United Nations Declaration on the Rights of Indigenous Peoples: Articles 3 to 6 and 46.
- The Forum attracted over 2000 indigenous peoples and NGO representatives.
- IFSW is represented on the Executive Committee by Elaine Congress, with an active role in planning a cultural event at the opening of the Forum.
- IFSW organized a side event to promote education, empowerment, and advocacy around self-determination for
  indigenous peoples. The event focused on the concept of self-determination and how it relates to the struggles
  of indigenous peoples who often are denied "free, prior, and informed consent," The well-being and survival of
  many indigenous peoples are continually challenged by large scale development projects to which they have not
  freely consented.

The panel provided historic and current examples of how indigenous peoples living on tribal lands, as well as in outside communities, are not permitted to exercise their rights to self-determination and concluded with a discussion of positive examples in which indigenous communities, despite obstacles, have been able to practice self-determination. Hilary Weaver, of American Indian Lakota background, Associate Dean at the University of Buffalo, School of Social Work, and President of the American Indian SW Education Association, Ronald Holloway, Chief of the Sand Hill Indians, and Sister Ellen Cafferty who has spent many years working with Maya people in Honduras and Mexico participated in this side event on May 16<sup>th</sup> that over 30 people attended.

## **Other UN Events**

The Global Social Work Student Conference was first held in 2008 as a supplementary event to Social Work Day
at the United Nations in New York. Since then, GSWSC has been a mainstay in the international social work
community in creating a space where social work students from around the world can come together to learn
and share ideas and information for best practice in the rapidly growing field of professional social work.

• IFSW interns planned and coordinated the **2014 Global Social Work Student Conference** at the UN Church Center. The theme was: The Future of International Social Work: Finding Careers and Engaging in the Post-2015 Development Agenda. More than 100 people were in attendance. The conference included a panel on UN and international careers followed by a workshop on the post 2015 development agenda.

# • Social Work Day at the United Nations –New York

The theme for the 31<sup>th</sup> Annual Social Work Day was "Social Work Practice and Education: Voices on the Post-2015 Development Agenda". The event was held in the North Lawn Building Conference Room 4 Room on April 28, 2014. After greetings from Darla Spence Coffey of Council on Social Work Education and Jeane Anastas of the National Association of Social Workers (USA), the morning's event began with a keynote address from Ambassador Simona-Mirela Miculescu, PhD, the Permanent Representative of Romania to the United Nations, and Vice-President of the General Assembly. Her presentation was well-received by the audience of approximately 350 social work students, faculty, NGO representatives and social work practitioners.

Additional speakers included Dr. Lakshmi Balaji, Chief, Strategic Planning, UNICEF, New York City; Mendy Marsh Gender-based Violence Specialist in Emergencies Programme Division Child Protection in Emergencies Cluster UNICEF, New York, and Cristina Diez Main Representative to the UN International Movement ATD Fourth World. An update on the Global Agenda was provided by Julia Watkins, IASSW and our IFSW President, Gary Bailey. Dr. Lynne Healy, Professor at the University of Connecticut School of Social Work and a member of the IASSW Executive Board was the wrap-up speaker. # **Department of Economic & Social Affairs (DESA)**

## Conference of States Parties to the Convention on the Rights of Persons with Disabilities (COSP).

The Convention on the Rights of Persons with Disabilities was adopted by the General Assembly by its resolution 61/106 of 13 December 2006. It came into force on 3 May 2008 upon the 20th ratification. Article 40 of the Convention stipulates that "The States Parties shall meet regularly in a Conference of States Parties in order to consider any matter with regard to the implementation of the present Convention." Since 2008, five sessions of the Conference of States Parties have been held at United Nations Headquarters.

- IFSW attended the 3rd session of the COSP (17-19 July 2013), with the theme; "Ensuring adequate standard of living: empowerment and participation of persons with disabilities within the framework of the CRPD". At the opening of the conference, International Disability Alliance Chair, Mr. Yannis Vardakastanis, speaking on behalf of civil society and NGOs in particular, highlighted the importance of mainstreaming disability in future global development goals, noting that this issue currently represents the most important advocacy activity for the disability community worldwide. The conference programme included thematic roundtables and an informal panel on economic empowerment through inclusive social protection; poverty reduction strategies; disability-inclusive development in national, regional and international processes; community-based rehabilitation and habilitation for an inclusive society; and an interactive dialogue on the implementation of the Convention.
- IFSW participated in an NGO side event at the COSP focusing on a mental health perspective on disability.
- The Seventh Session of the Conference of States Parties to the Convention on the Rights of Persons with Disabilities will take place from 10 to 12 June 2014 at the UN Headquarters, in New York. IFSW delegation will participate.

## High level Dialogue on International Migration and Development

In 2013, the number of international migrants worldwide reached 232 million. Migration can bring substantial benefits, but can also have negative consequences. Both developing and developed economies need migrants to meet the demand for workers with different levels of skills. In brief, migration in the context of globalization brings opportunities and challenges, which need to be addressed in a comprehensive fashion. This is why the UN convened the High-level Dialogue on International Migration and Development from 3-4 October 2013 with an eight-point agenda for action on making migration work.
