The Nominee has participated in Regional meetings, conferences and planning.

The Nominee has worked in the area of Community Development, Community Services in a Refugee setting, Child Rights and Child protection, Public Health, Advocacy/Community Based Social Accountability, HIV community based prevention and systems strengthening (Social Welfare Workforce strengthening). The Region faces a lot of problems ranging from Civil wars, refugee crisis, economic turmoil, unemployment, HIV and AIDS, Malaria, and Poverty. There is currently a high burden of Children without appropriate care. While the region is characterised by multi-lingual members, the Nominee has been able to work in multicultural communities as well as communicate with people of diverse languages.
