a) Commitment to the goals of IFSW as laid down in the Constitution

Aims of IFSW:

I) To promote social work as a profession through international co-operation, especially regarding professional values, standards, ethics, human rights, recognition, training and working conditions;

As Regional President, I have made significant achievements in the region and globally. These include, ensuring that all LAC members are fully up-to-date with their IFSW membership requirements, supporting new membership applications from Paraguay, Honduras and Guatemala, supporting national professional conferences and events in Cuba, Uruguay, Peru, Chile, Brazil, Colombia, El Salvador, Mexico and Panama, a regional conference in Puerto Rico (2015) y Costa Rica (2017); as well as facilitating regional development and unity across the 17 LAC members of IFSW. Internationally, I also attended a global executive meeting in Melbourne, Australian (2014); Switzerland, Geneve (2015) and Basilea (2016); Soul, South Korea (2016) and I participated in a congress in Spain with the aim of strengthening ties between Latin America and Europe.

Each of the above actions has significant assisted the development and strengthened the social work profession. I have also been able to present the LAC view and perspectives in the development of global social work policy, statements and interventions which has directly assisted the rapid growth, status and influence of the profession.

As President of Argentine Federation of Professional Associations of Social Service I have promoted studies about working conditions of social workers that were presented in Regional Meeting of Mendoza, Argentina Republic, on August 2011. I have also participated in Working Conditions Study of Social Workers of Latin America and the Caribbean presented in Regional Meeting of Santiago, Chile Republic, on April 2014.

As President of Argentine Federation of Professional Associations of Social Service I have also promoted the discussion and exchange of ideas and experiences in Regional Workshop made in Río de Janeiro, Brazil, on 8 March 2012. In the same sense I have promoted the publication of documents about ethic and human rights that it was sent to IFSW.
