For most of my social work career, I have worked in child welfare, in child protection service and more specifically in the investigation of deaths of children associated with the child welfare system. Later, I worked in one of the four administrative Authorities for child welfare in Manitoba with a particular focus on improving practice in the assessment of safety and risk with respect to the reports of children in need of protection.

During the past ten years, I have had a number of roles, both at the Office of the Chief Medical Examiner and at the General Child and Family Services Authority where, as a Senior Manager, I supervised other workers in the oversight of a number of child welfare organizations in Manitoba. I later served the General Authority as Inquiry Coordinator at a public inquiry into the death of a child, representing the Authority when and as needed.

I have spoken to social work classes about the practice of social work, risk assessment and the regulation of social work practice.

From personal research, I know that a story by a reputable source in a reputable newspaper may have absolutely no basis in fact or reality. I kept this article for years as a reminder that because something is written (or reported) doesn't make it truth.
